Prior to listing, we refurbish your jewelry to "showroom condition" and may also arrange an independent appraisal to determine current market value. We consign Krikawa-made jewelry in "good or better" condition that has the potential for resale. We are paid for refurbishing services and retain a percentage when the item sells. We pay you based on the actual selling price within 20 days after your item sells.

How the Selling Price is Determined:

Krikawa initially sets the advertised selling price at 80% of current market value. Factors considered in determining current market value are current price of materials, relevancy of style, previous repairs, quality of diamonds and gemstones, and independent valuations. In some instances, Current Market Value may be less than what you originally paid. We will not sell your jewelry below the Advertised Selling Price without your consent. Our fees are based on the actual Selling Price.

Inspection, Refurbishing Fees:

We evaluate your jewelry free of charge to assess its condition and potential for resale based upon style, degree of customization, and our experience about what is likely to sell. Although we see value in pre-owned rings for budget conscious couples, there is an unwarranted stigma associated with used relationship jewelry. If we decline to consign your jewelry, we will return it to you.

We will provide you with a quote for refurbishing work to bring the piece to saleable condition. We collect the refurbishing fee upfront and complete the necessary work prior to listing. If you decline the quote, then we will return your item to you.
